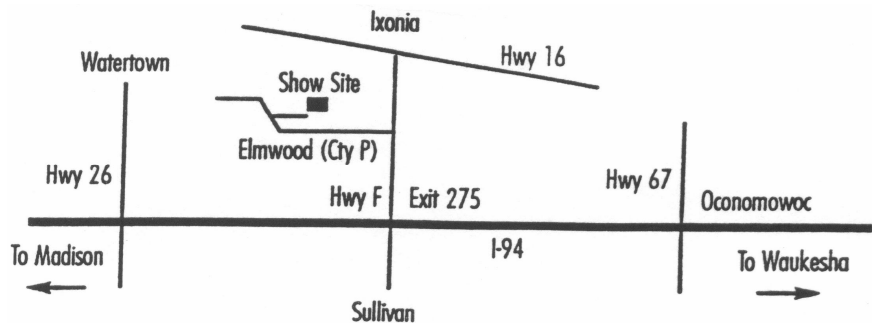
instructions for the type of vaccine used.

DIRECTIONS TO TRIAL SITE:

From I-94 Exit #275 Cty F Ixonia-Sullivan. Go North on Cty F about 4 miles. Turn West (left) on Elmwood Drive (Cty P) - Just before the train tracks. Turn Right on Cedar Dr. Our building is at the end of the drive on the left.

IMPORTANT—IF YOU ARE COMING FROM THE EAST ON 1-94, DO NOT GET OFF AT EXIT 295 (CO. HWY F IN WAUKESHA COUNTY). CONTINUE TRAVELING WEST TO EXIT #275, County F in Jefferson County.

From the East: Take HWY16 (to about 5 miles west of Oconomowoc). Turn South on Cty F (Ixonia). Turn Right on Elmwood (Cty P) - First right after train tracks. Turn Right on Cedar Dr. Our building is at the end of the drive on the left.

ADDITIONAL INFORMATION

Move ups will be allowed in accordance with the Obedience Regulations Chapter 1, Section 16.

Only dogs entered in trial are allowed on the grounds. We request that any dog causing a disturbance be removed from the Ring area. All dogs must be on leash except when being judged.

Entries should be typed or printed, except for the proper signature, on Official AKC entry forms only.

If because of weather, riots, civil disturbances, or other acts beyond the control of MDTC it is impossible to open or to complete this show, no refund of entry fee will be made. In the event of extreme weather, this show may be cancelled.

A refund of entry fee minus \$10 for an entered bitch that comes in season after entries close will be made upon presentation of a statement by a licensed veterinarian to the Trial Secretary by 8 a.m. the day of the show.

Exhibitors from outside Wisconsin must comply with the following regulations. Wisconsin Dept. of Agriculture effective date: June 11, 1996 Last up date: Feb. 9, 2001.

Dogs and domestic cats must be accompanied by a certificate of veterinary inspection that shows the status of the last rabies vaccination, including the date of rabies vaccination and the date the animal is due for re-vaccination. Rabies vaccine must be administered by a licensed veterinarian. Vaccine shall comply with age, time standards, and label instructions for the type of vaccine used.

TRIAL INFORMATION

ENTRY FEES: Obedience & Rally \$26.00 each

Entry fee for additional entry of same dog: \$18.00 each

Fees include 50 cents American Kennel Club Recording Fee plus \$3.00 service fee for obedience and 3.00 per entry for rally.

Entries close at the Trial Secretary's address, **WEDNESDAY NOON, MAY 23, 2012**, unless the numerical limit is reached prior to the date after which time entries will not be accepted, cancelled, altered or substituted.

MAKE ALL CHECKS/MONEY ORDERS PAYABLE TO MDTC. Canadian exhibitors must make fees payable in U.S. funds. Exhibitors whose checks are returned for NSF will be assessed a \$20.00 service fee. Entries will not be accepted if received without signatures, fees and back of entry form with agreement. An official American Kennel Club entry form must be used. Telephone and telegraph entries cannot be accepted. No entry will be accepted which is made subject to conditions.

Bitches who come in season after the closing date will have the entry fee less \$5.00 refunded upon written certification by a licensed veterinarian to the effect that the bitch in question is in season on the day of the trial. NOTIFICATION MUST BE RECEIVED BY THE TRIAL SECRETARY BEFORE 8 A.M. (CST), Saturday, June 9 or 10, 2012

Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by veterinarian or judges, or barred from competition by action of the Trial Committee. If, because of riots, civil disturbances or other acts beyond the control of the Trial giving Club, it is impossible to open or complete the Trial, no refund of entry fees will be made.

EXHIBITOR INFORMATION

1. Building is air conditioned and heated. Trial grounds are not available the night before the trial
2. No dogs on grounds except those properly entered.
3. MDTC and/or WWCDTC assume no responsibility for any injury sustained by exhibitors, handlers or their dogs or property and further assumes no responsibility for injury to an exhibitor's child. Exhibitors must exercise control of their children at all times while within trial grounds.
4. Dogs need to be present only for scheduled time of judging and may be removed immediately after judging unless required for further judging. Dogs judged in catalog order to extent it is practical without holding up judging in another ring. Judges are not required to wait for dogs and it is exhibitor's responsibility to be ready at ring-side without waiting to be called.
5. Keep show site clean; pick up after your dog.
6. No private exercise pens are permitted in the building. Use designated exercise areas only.
7. No dogs may be left in building over night.
8. Move ups will be allowed.
